DREW ALI' loadcrship ras soon contcsted. In 1929 he became embroiled in a quarrel tith CLiUDE GREENE, politician and former butler of JULIUS ROSENKALD, who previously had joined the temple. One day DREI arrived at his office to find that GREEiV had moved all the furniture outside and declared himself Grand Sheik. A civil var ensued, each faction enlisting support from temples in other cities. GREENE was shot and stabbed to death in his offices at the Unity Club on the night of march 15, 1929.

DREF ALI, arrested as he sat inth his wife and group of followers celebrating $/$ (authorities charged) the murder of his rival, was defended by ittorneys AARONPAYNE and WILIIAN LXTANSON, temple members tho later gained political prominence. The Prophet, from prison, issued a message to his flock:
"To the Heads of all Temples, Islam:
"I, your Prophet, do hereby and now write you a letter as a warning and appear to your good judgment for the present and the future. Though I am now in custody for you and the cause, it is all right and it is well for all who still believe in me and my father, God. I have redecmed all of you and you shall be saved, all of you, even with me. I go to bat Monday, Kay 20, before the Grand Jury. If you are with me, be there. Hold on and keep faith and great shall be your reward. Remember my laws and love ye one another. Prefer not a stranger to your brother. Love and truth and my peace I lcave all.
"Pcace from
Your Prophct
NORLE ROTA ALI"
This proved to be DREN ALI's final oficial proclamation. Released on bond, he died under fysterious circumstances a fow woeks later. One theory is that he succumbod to injuries inflicted by the police during his imprisonment, another is that ho was set upon by partisans of GREENE after his relcaso and beaton so severcly that he never rccovercd.

After DREw ALI's dcabh attorncy 4 ARON PAYNE attcmptod unsuccessfully to hold the group together. Each among several of the Prophet's disciples antounecd that he alonc was the rightful inheritor of DRE/ ALI's lifdership. JOHN GIVENS EL (formcrly the Prophet's chauffour) and IRA JOHNSON EEY (who had bocn imported from Pittsburgh to assist in queling the GREENE revolt)

Invest gation shows that all members of SHELBY Branch have complied with the Selective Service Laws and there are no delinquencies reported in their Selective Service status. The Selective Service recorco of Draft Board No. 2, 3104 South Michigan, show that Brother dy 4 SHEBI IL, Shaik, was born June 4, 1826, at Clarksville, Tennesses. He stated in hís Occupational Questionneire that he was the savior of the world. The investigation conducted thus far has shown no indication that there are any pro-Japanese sentiments or subversive activities being conducted by this organization.

The investigation further shows that J. SHELBY EL and ALBERT STRICKLAND, who is an assistant to SHELBY, attempted to organize a branch of the Moorish Science Temple near Vilestone, Kississippi, which resulted in the arrest of - seviral membirs at lijestone during which time SHELBY and STRICILAND returned to Chicago, there prescntly being an indictment outstanding against them in the State of Mississippi. The dotails of this will be found in the investigation conducted in the Jackson Field Division.

This group of the Moorish Science Tcmple of America is under the leadership of EL, who calls himsclf was one of the leaders of the subject organization at the time pren ali was alive, and following his death aspircd to its leadershion EL was successful in atitracting folloatine
once 1930 the group has been meeting at 447 East 40 hn burect ontrinesory and Friday evenings, and Sunday afternoons. Therc have been several menbers of the organization living at 447 East 40 th with the Subject and the vast majority of the members are residing in the immediato noighborhood. The membership has been estimated from 60 to 150 porsons in Chicago, Illinous. Feportedly has fiye wivas living with bim at
 From information reportce to the Chicago Ficld Division, has boen pro-Japanese in the past. An informant advised tha has not taken in ncw mumbers into the subject organization but that in 1932 and 1933 was active in telling members that the Japanesc werc the friends of the colored man, and that whon the Japancse ceme and conquerod America that they would see that the Negro received his fair sharo in governing this country.

An invostigation conductod by the Chicago Fiald Offico has not ostablishod that statoments at the prescnt time mado by

nature. The investigation of the male members of the Branch reflects that they have complied with the requirements of the Selective Service Act. Subject EL is registered in accordance with the Act and has claimed his common-law wife EL and the three children as grounds for deferment. who is years of age, has been classified III-H by his local board.

This group has been reported to be extremely well financed by contributions received from members located in different cities principally along the East coast as will be developed further in this report. This group is also more fanatic and more closely resembles a cult group than do other branches of the Moorish Science Temple, male members of this branch wearing long beards and red fezzes, and women members wearing long flowered gowns and colored turbans. Enjoys a dictatorship status over the members of this branch. A school 15 conducted by EL for the children in the subject organization. $\quad$ former bohol teacher, is reported to tach fundamentals of grade school education as well as the Moslem and Islam Religion,

The male members of this branch are employed in domestic positions and regularly contribute to the support of and his rives and children.

This branch of the subject organization has been inactive for sometime. EL was a member of the Adept Chamber while NOBLE DREIT ALI was alive. Following the death of NOBLE DREW ALI at a meeting of the Adept Chamber, EL was allegedly elected to be the Grand Shiek of the subject organization. However, he was not successful in retaining the Icadership and attracted only a few persons to his group. However,

EL has filed with the Secretary of State at Springfield, Illinois, every year since 1938, and has received the State Charter. This is the only group on record with the Secretary of State. Meetings of this group were formerly held at 4848 South State Street until April, 1942, but since this time meetings have not been held.

Subscuently EL adviscd that in discussing the lotter ho had rocoibd wit EL, leader of Branch 1, 3122 South Cottage Grove ivomuc, that EL stated that ho had recoived a similar letter but had declined to acespt the foyitation. that on intcruicw housc in 1938 and chactevored to pirsuace 11 m to sympathize with tho Japanose cause. $\quad$ Ll advised that ho had nevor know the identity of the Japanesc celling on him, and he further stated that as soon as their purpose becamo clcar, he invited them to lcave his houso, stating that Amcrica was tho only country with which he vas familiar and, thereforc, he would do nothing to hurt the United Statcs.

EL further adviscd that the total membership was not oucr ten persons, and that for that reason mectings wore discontinued in the Sprine of 2942. He advised, howover, that he and EL, the wore discussing the advisability of agan holding pootings or thes branch of tho subfect organization. EL insisted that under the tcachings of Prophot NOBLE DREW ALI that mctuotrs of the subject organization mast abide by the laws of tho Unitcd Statos, and must place their loyalty to this country in times of omergency.

This brench of the subject organization, under the Ioadership of EL, mects at 322 East 43rd Strcot Chicago, Illinois, on Friday and Suroay evenines at 8:00 En.m. EL, and sy, came to tho chicago ricmarurice on Septenber cis, 1342, to advise that thicir organizavion was in no way connected with the ilis Temple of Islam, although nowspaper stories of the arrcst of the Hoslems had indicatod thet they vere in fact conncetod with the koorish Science Tcmple of amcrica. EL advised that his branch has 36 members and its officers are as follows:



EL advised that members of this group abide by the teachings of NOBLE DREW $14 I$ and that the members are taught to comply with ail lays and regulations of the United States. Each of the three Individuals above referred to - exhibited Selective Service cards and advised that all members have been instructed specifically to comply with the requirements of the Selective Service Act. They advised further that the Koran used by this organization was printed by one IL advised that members of his group hic never been in conflict with tiocincago Police Department, and that all member $\$$ were employed at responsible positions, including many defense plants.

With reference to $\square$ BEY $\square$ the Chicago Field Division received a letter datainotober 6, 1942, From Chicago Local Board No. 7. $\qquad$ of Draft Board No, 7 advised that,

and that he was born in and had listed on his Selective Service
Registration Card that his race was Oriental. In a questionnaire followed by 8EY, he stated he mas opposed to noncombatant military service. He mentassificd III $A$ on 2945. The Board received a letter dated 1942, from which ho returned a special form for Conscientious objector and stated that he was not opposed to tho Selective Service Act, and any objections made by him to tho Selective Service hot Fore a mistake. In this letter ho claimed to bc a Moorish American and to be a part of the United States Government.

## PROSECUTIVE STEPS
